

RED RIVER HOOPS ASSOCIATION PARENT AND PLAYER CONTRACT

- 1. Parents Parents understand that they too represent our team, community, and basketball program. As a parent(s), you agree to show your belief in your child, their teammates and coaches, and demonstrate methods to reinforce positive self-esteem. You will also do your best to attend your child's games to show that you are proud of them. Parents agree to encourage and cheer for the team in a positive fashion during games and to refrain from rude or obnoxious behavior or comments toward the opposing team and officials. Parents should never confront referees or other game personnel this is solely the province of the coaching staff. Parents should respect and support the decisions of the coach. As a parent, you understand you must get involved in fundraising to sustain the needs of our basketball teams and volunteer to work during home games. Each family will be **required** to work at **least three (3) fundraisers per year.** Two (2) parents are expected to work the game clock and official scorebook for each home game. Two (2) parents will also be expected to work the concession stand. In the absence of volunteers, parents will be assigned these tasks on a rotating basis.
- 2. Problems If a parent or player has any problem with a coach or other team related matter, the parent or player should FIRST speak directly with the head coach. If the parent or player is unable to do so or is unsuccessful in doing so, the next line of communication is with the Director of Operations. All issues should be addressed in an appropriate manner, bearing in mind the expertise and judgement of coaches should be respected, particularly when it comes to positions and playing time. If the problem is still not being adequately addressed, the issue may be raised with the Red River Hoops Association Board of Directors at a meeting, typically held on a monthly basis.
- 3. Player Conduct As a member of a Red River Hoops team, each player represents and serves as a reflection of their coaches, their team, their family and their community. Players must agree to conduct themselves responsibly both on and off the court, display sportsmanship on the court and demonstrate concern for the rights, safety and welfare of others off the court. All players agree to treat their coaches, teammates, competitors and referees with respect and courtesy. Players agree to always work hard, to learn as much as they can to improve their individual skills and contribute to the success of the team. While all players should have fun, this is not the sole goal of the program. The Red River Hoops experience requires commitment and dedication on the part of the player, their family and the coaches. The objective of the program is to develop advanced basketball skills while at the same time, learning the values of hard work, preparation and teamwork.

As a player, you commit to always do your best, whether it is during a practice or a game. In doing so, you will always know you have no one to blame but yourself if you give less than your best. Behavior that shows disrespect toward other players, coaches, referees or demonstrates lack of self-control will be subject to discipline. This includes the use of profanity. The coach will determine all appropriate

disciplinary actions. Should the behavior continue to be inappropriate, the coach may seek the removal of the player from the team, subject to approval of the Red River Hoops Association Board of Directors.

All players who are members of Red River Hoops understand playing basketball demands tremendous commitment and dedication to the game and their team. Likewise, parents make great commitment and sacrifice for their child to play with the team. Playing for our team is a privilege, not a right. As Red River Hoops players and parents, we understand and agree to follow the contract.

Player Responsibilities:

- 1. All players will treat officials and opponents with dignity and respect.
- 2. All players, regardless of ability and/or playing time, are equal members of the team. Every player will treat all teammates with acceptance, respect, and friendship.
- 3. All players will provide maximum effort in practice and in games.
- 4. Attendance at all practice, team meetings, and games is strongly encouraged.
- 5. In the event a player must miss practice or an event, parents or players are responsible for informing the coach, with a phone call or a text message, at the earliest possible time.
- 6. Players are to be on time for all practices and games. Tardiness may affect playing time during games.
- 7. Players are expected to directly seek understanding and resolution when questions or problems arise with coaches and teammates.
- 8. Players will conduct their personal lives in a manner that brings honor to themselves and the team. This includes school performances, self-respect, healthy behaviors and social responsibility.
- 9. Players will participate in the raising of monies needed to sustain the needs of the basketball program regardless of the amount of playing time given.

- 1. FOR MYSELF, SPOUSE, AND CHILD, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my child's participation; and:
- 2. I willingly agree to comply with the program's stated and customary terms and conditions for participation. If I observe any unusual, significant concern in my child's readiness for participation and/or in the program itself, I will remove my child from the participation and bring such attention to the nearest official immediately; and:
- 3. I myself, my spouse, my child and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS Red River Hoops Association, it's directors, officers, officials, agents, employees, volunteers, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH or loss or damage to person or property incident to my child's involvement or participation in these programs, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
